

ON OCTOBER 31, 1997, AT 16:00 HRS. I ATTENDED A VIDEO TAPED INTERVIEW WITH [REDACTED] IN FARMINGTON AT THE STRAFFORD COUNTY ATTORNEY'S OFFICE.

CONDUCTING THE INTERVIEW WAS NANCY HARRIS AND THE PURPOSE OF THE INTERVIEW WAS TO DETERMINE WHETHER [REDACTED] WAS A VICTIM OF SEXUAL ASSAULT. AT THE BEGINNING OF THE INTERVIEW, MS. HARRIS ASKED [REDACTED] IF HE KNEW WHY HE WAS AT THE INTERVIEW. AT THAT POINT [REDACTED] SAID, "BECAUSE FATHER ROGER HAD MOLESTED HIM WHEN HE WAS FOURTEEN YEARS OLD".

FATHER ROGER WAS THEN IDENTIFIED AS FATHER ROGER FORTIER, A FAMILY FRIEND AND PASTOR AT SAINT PETER'S CHURCH IN FARMINGTON. [REDACTED] STATED THAT HE FIRST MET FATHER ROGER WHEN FATHER ROGER BEGAN TRAINING HIM TO BE AN ALTER BOY AT SAINT PETER'S CHURCH. [REDACTED] STATES THAT THIS TRAINING BEGAN IN 1990 OR 1991, [REDACTED] STATING THAT HE WAS IN THE FIFTH GRADE AT THAT TIME.

[REDACTED] SAID IN HIS INTERVIEW, NORMALLY THE TRAINING WOULD TAKE PLACE ON SATURDAY MORNINGS. HE ALSO SAYS THAT THERE WERE FIVE BOYS THAT TOOK THIS ALTER BOY CLASS WITH HIM. WHEN ASKED TO IDENTIFY THE BOYS, [REDACTED] COULD NOT REMEMBER THEIR NAMES.

[REDACTED] STATES THAT THE FIRST INCIDENTS WITH FATHER ROGER TOOK PLACE IN JANUARY OF 1994. [REDACTED] STATES THAT THIS WAS JUST AFTER HIS BIRTHDAY AND FATHER ROGER HAD JUST RETURNED FROM ST. LOUIS, WHERE HE WAS SENT BY THE DIOCESE. [REDACTED] SAYS HE WAS AT THE RECTORY WITH FATHER ROGER WATCHING A TELEVISION SHOW, WHEN FATHER ROGER MADE SOME OFF COLORED HOMOSEXUAL COMMENTS CONCERNING A MALE INDIVIDUAL THAT WAS ON THE PROGRAM. [REDACTED] STATES THAT THE FIRST INCIDENT OF SEXUAL ACTIVITY TOOK PLACE IN EITHER JANUARY OR FEBRUARY OF 1984. AT THAT TIME FATHER ROGER AND [REDACTED] WERE AT THE RECTORY AT SAINT PETER'S CHURCH. FATHER ROGER OFFERED [REDACTED] SOME ALCOHOL IN THE FORM OF A MIXED DRINK, CALLED A SCREWDRIVER. [REDACTED] SAID THAT HE DRANK THE FIRST AND THEN FATHER ROGER OFFERED HIM A SECOND. [REDACTED] SAID THAT HE ACCEPTED THE SECOND DRINK, HOWEVER, ASKED HIM NOT TO MAKE THE SECOND ONE AS STRONG AS HE HAD MADE THE FIRST ONE. SHORTLY AFTER THE BEGINNING OF THE MOVIE, [REDACTED] STATES THAT FATHER ROGER CAME OVER TO THE RECLINER AND BEGAN RUBBING

[REDACTED] AT THAT POINT, APPARENTLY AGREED TO DO THIS AND FATHER ROGER LED HIM TO THE BEDROOM, LAID HIM DOWN ON THE GUEST BED, IN THE GUEST BEDROOM, AND BEGAN TO SUCK [REDACTED] PENIS AGAIN. HE CONTINUED TO SUCK [REDACTED] PENIS TO THE POINT OF EJACULATION, FATHER ROGER THEN BEGAN TO MASTURBATE HIMSELF. AT ONE POINT HE GRABBED [REDACTED] HAND AND PUT IT ON HIS PENIS AND MADE [REDACTED] MASTURBATE HIM. [REDACTED] STATES HE REFUSED TO DO THAT, BUT DID RECALL THAT FATHER ROGER AFTER THE REJECTION ROLLED OVER AND BEGAN SUCKING ON [REDACTED] PENIS. FATHER ROGER ASKED [REDACTED] TO COME UPSTAIRS AND AT THAT POINT SAID TO [REDACTED] "YOU CAN USE MY CAR", THEN ASKED [REDACTED] "DO YOU HAVE TIME?" [REDACTED] STATES THAT FATHER ROGER LED HIM TO HIS BEDROOM WHERE HE LAID [REDACTED] DOWN ON THE BED, STRATLED HIM, AND SUCKED HIS PENIS TO THE POINT OF EJACULATION. WHEN THIS ACTIVITY WAS FINISHED, FATHER ROGER THEN GAVE [REDACTED] THE KEYS TO HIS CAR, WHICH WAS A GRAY SATURN, ACCORDING TO [REDACTED]

FATHER ROGER LED TO HIS BEDROOM, LIED DOWN ON THE BED, STRATTLED HIS KNEES AND BEGAN SUCKING ON HIS PENIS. HE CONTINUED THIS ACTIVITY UNTIL EJACULATED AT WHICH POINT FATHER ROGER GOT OFF OF HIM, CLEANED HIMSELF UP AND ESCORTED HOME.

STATES THAT THE LAST TIME THERE WAS ANY TYPE OF SEXUAL ACTIVITY, WAS AT THE BEGINNING OF AUGUST OF 1997. STATES THAT HE WENT TO THE RECTORY BECAUSE FATHER ROGER HAD AGREED TO LEND HIM EIGHT HUNDRED DOLLARS SO THAT HE COULD BUY A CAR. SAID THAT HE CAME TO THE RECTORY IN ORDER TO GET THIS MONEY AND THEN WAS GOING DIRECTLY TO MAKE THE PURCHASE OF THE VEHICLE. FATHER ROGER CAME TO THE DOOR, GAVE THE MONEY, AND THEN ASKED HIM, "DO YOU HAVE TO RUSH OFF?" STATES AT THAT POINT FATHER ROGER GRABBED HIM AND LED HIM TO THE NEW COUCH IN THE LIVING ROOM AREA. AT WHICH POINT FATHER ROGER KNELT DOWN BETWEEN LEGS AND SUCKED HIS PENIS UNTIL EJACULATION.

DURING THE INTERVIEW, DESCRIBED FURNITURE WHICH IS IN THE RECTORY. DESCRIBES OLDER FURNITURE WHICH HE STATES HAS SINCE LEFT THE RECTORY WITH THE PURCHASE OF NEW FURNITURE BY FATHER ROGER.

ALSO STATED DURING THE INTERVIEW THAT HE FELT FATHER ROGER HAD TAKEN ADVANTAGE OF HIM. HE ALSO SAID THAT AT TIMES HE FELT LIKE "HIS BOY TOY". WHEN ASKED WHAT HE MEANT BY THAT, SAID THAT FATHER ROGER KNEW THAT IF HE BOUGHT THINGS, WOULD AGREE TO DO, TO ENGAGE IN THIS TYPE OF ACTIVITY. ALSO STATED THAT HE DIDN'T KNOW IF THIS WAS WRONG, WHAT HE WAS DOING WITH FATHER ROGER. HOWEVER, HE KNEW THAT HE WAS GOING TO GET PRESENTS FROM FATHER ROGER IF HE WOULD ENGAGE IN THIS ACTIVITY.

ALSO SAID DURING THE INTERVIEW, THAT FATHER ROGER GOES TO ATLANTA, GEORGIA WHERE HE HAS A FRIEND. THIS FRIENDS NAME IS A FIFTY-EIGHT YEAR OLD MAN, WHO ACCORDING TO IS A HOMOSEXUAL. STATES THAT WHEN FATHER ROGER WOULD GO TO ATLANTA, GEORGIA TO VISIT MR. THAT THE TWO WOULD GO OUT TO BAY BARS AND WOULD PAY OTHER MEN MONEY TO HAVE SEX WITH THEM. ALSO STATES THAT SEVERAL TIMES FATHER ROGER ASKED IF WOULD ACCOMPANY HIM TO ATLANTA TO VIST MR. STATES THAT

MS. HARRIS ASKED [REDACTED] IF HE THOUGHT THAT FATHER ROGER WAS IN A POSITION OF AUTHORITY AND [REDACTED] AGREED THAT HE WAS. [REDACTED] STATED THAT FATHER ROGER IS THE HEAD OF THE ALTER BOYS AND IN CHARGE OF THE ALTER BOYS OF WHICH HE WAS ONE.
